You will work with our Policy & Advocacy team. This role offers a unique opportunity to gain hands-on experience in policy and advocacy at the European level.

Responsibilities

- Conducting research and drafting policy briefs, position papers, and reports to support FEBA's advocacy towards the EU institutions.
- Evaluating and scrutinizing the agendas, legislative proposals, and decisions from key EU bodies such as the European Commission (DG SANTE, DG ENV, DG AGRI, DG EMPL), the European Parliament (AGRI, ENVI, EMPL Committees), and the Council of the EU.

- University degree or relevant academic background in International Relations, Political Science, European Studies, Law, Environmental Studies, Social Policy, or related fields.
- Students currently enrolled and requiring a curricular traineeship are not eligible for consideration.
- Strong interest in food systems, food waste prevention, social policies, and EU policymaking.
- Good understanding of EU institutions, policy-making processes, and stakeholder engagement.
- Excellent research, analytical, and writing skills.
- Fluency in English (written and spoken).
- Strong organisational skills with the ability to work independently and manage multiple tasks.
- Excellent communication and interpersonal skills, with the ability to engage effectively in a multicultural environment.
- Proficiency in Microsoft Office.
